AKC Agility Trial Judging Schedule
January 27, 2017 – Judge: Terry Elger

This trial is being held at Car-Dun-Al's facility, 10783 Wolf Drive, Huntley, IL. The training center is in the southwest corner of the second building to the west. The building will open at 6:30 a.m. No barking dogs will be allowed to remain in vehicles, they must be crated inside. Please contain your crating areas. While this day's trial is not full, the weekend days are and will need all available space possible. RVs are allowed only during trial hours on the south side of the building and parking lot along the grassy area of the driveway. They must overnight at one of the local RV parks (Chicago Northwest KOA at 815-923-4206 or Lehman's Lakeside RV at 815-923-4533. In case of emergency, you may contact the secretary the weekend of the trial, call (630) 673-7643.

Except for the first class of the day in each ring, all start times are approximate. Numbers in each class/jump height are preliminary, and may change based on move ups received. Dogs in the Master classes will run first, followed by dogs in the Excellent classes for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height and division. Walk throughs will be split at the discretion of the judge.

There will be two VMOs at this trial, therefore any exhibitor whose dog does not have a valid permanent or temporary height card must be measured prior to running in their first class. All other exhibitors need only check in with the gate steward at the start of their class.

DIRECTIONS: From the east, take I-90 to the Route 47 exit and go north approximately 3.7 miles to Oakcrest Drive (Algonquin Road to the right) and turn left. Go less than .1 miles on Oakcrest and turn left onto Wolf Drive.

From the west, the Route 47 exit is now open, however it is electronic only! If you do not have I-Pass, you will have to take I-90 to the Route 20 exit or pay online. If you use the Route 20 exit, go west (left) at the light at the end of the ramp and drive approximately 1.6 miles to Harmony Road. Turn right on Harmony and drive 3.7 miles to the stop sign, then turn left to stay on Harmony Road. Drive to the next stop sign and turn right (Main Street). Drive 1.4 miles on Main Street to Route 47 and turn left. Go .4 miles north on Route 47 to Oakcrest Drive (Algonquin Road to the right) and turn left. Drive .1 miles to Wolf Drive and turn left. I-Pass users can exit at Route 47 and go north, following the directions above from the east.
