**ENTRY:** Entry fee is \$24 for the first entry, \$15 for the second entry, \$12 for the third entry and \$10 for the fourth entry of the same dog, per day. Mail entries, maximum of 10 per envelope, with fees payable to GABOC, to Beth Elliott, 9N909 Koshare Trail, Elgin, IL, 60124. Envelopes containing more than 10 entries will be returned in their entirety. Express mail entries must waive the signature requirement, or they will be refused. Exhibitors are responsible for complete, accurate, and legible information on their entry forms, and the correct entry fee. Please do not use staples to attach checks and/or height cards to your entry! Checks returned due to non sufficient funds will be assessed a \$25 fee. All illegible or incomplete forms, or those with insufficient entry fees, will be returned, no attempts by email or phone will be made!

**MOVE-UP REGULATIONS:** Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the trial secretary only. Move-ups for Saturday January 28<sup>th</sup> must be received not later than 6:00 p.m. on Monday January 23<sup>rd</sup>. Move-ups for Sunday January 29<sup>th</sup> will be accepted on Saturday January 28<sup>th</sup> until the last ribbon has been awarded. Dogs so moved up will be entered at the end of the running order, and every effort will be made to accommodate handlers running multiple dogs in the same class.

**CLASSES:** All Standard, Jumpers and Premier classes will be offered. There will be no FAST, T2B, ISC or non-regular classes at this trial. Running order will be Premier Jumpers, Master/Excellent Jumpers, Premier Standard, Master/Excellent Standard, Open Standard, Novice Standard, Open Jumpers, Novice Jumpers.

**NOTICE TO EXHIBITORS:** Entry fees will not be refunded in the event that a dog is absent, excused, disqualified, or barred from the competition by action of the Show Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Bitches who come into season or any dog sustaining an injury after the closing date may have their entry fee returned, less an administrative fee, by providing the trial secretary with a signed statement from a veterinarian at least ½ hour before judging begins.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.

Dogs are not required to be at the trial until the scheduled time of judging, however handlers arriving after the scheduled course walk through for their class has taken place are not guaranteed a chance to walk the course. All dogs not needed for further judging are excused. The owner/handler is solely responsible for having it ready at ringside when the class is to be judged. Conflicts between rings should be discussed with the judge prior to the start of the class and the gate steward notified.

All dogs must be on leash at all times except when in the ring or when in the designated warm-up areas. Exhibitors and spectators are expected to keep the show grounds clean. Please pick up after your dogs. Anyone witnessed not picking up after their dog will be excused from the trial weekend with no monies refunded.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Exhibitors are required by DuPage County and the state of Illinois to maintain proof of either rabies vaccination or titer.

This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

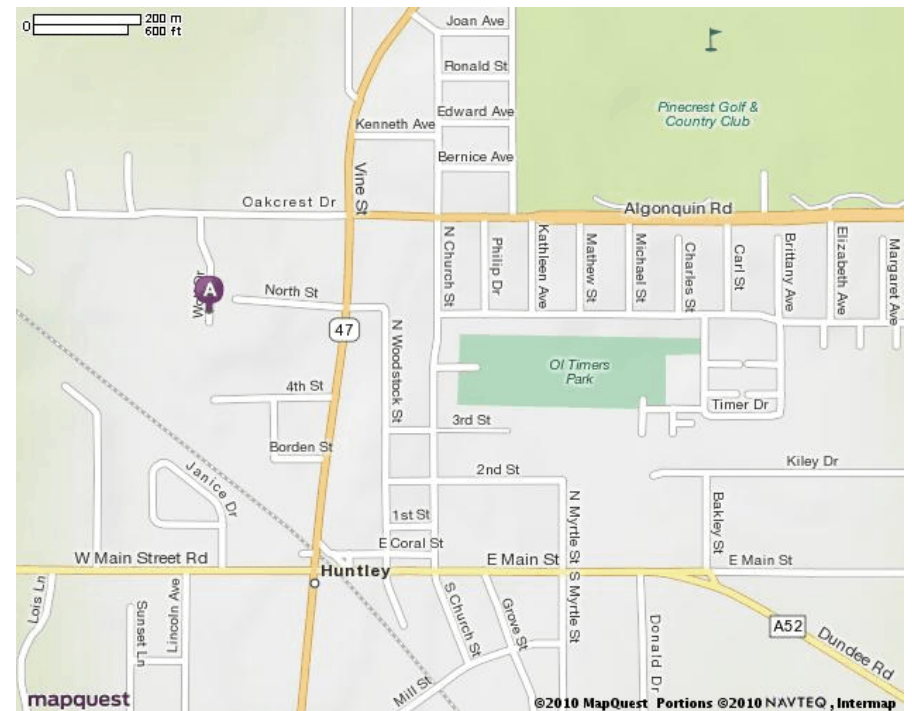
**SITE INFORMATION:** The agility trial will be held at Car-Dun-Al's training facility, 10783 Wolf Drive, Huntley, IL. The training center is in the southwest corner of the second building on the right. It will be indoors on 3/4' agility matting. There will be no barking dogs allowed in vehicles, they must be crated inside. Fast food restaurants are nearby. Any additional questions regarding the site and its amenities should be directed to the trial chairman.

Directions to the site are as follows:

From the east or west, take I-90 to the Route 47 exit. Go north on Route 47 approximately 3.7 miles to Oakcrest Drive and turn right (known as Algonquin Road to the right). Go less than .1 miles on Oakcrest to Wolf Drive and turn left.

If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
